- II. For Cash In Safe and Cash On Counter Insurance Coverage, Bank shall not provide Gunman/ Fire Arm Service. Only regular arrangement (CCTV and Security Guard) will be available for Branch/ Sub-Branch/ Head Office/ ATM booth/ Collection Booth security. Bank shall ensure the said security through our BBB Insurance Coverage as per Bank's convenience and discretion. Hence, you are request to submit your offer accordingly.
- III. "BBB Insurance Coverage" for our Bank may be shared among the Insurance Company i.e. one of the Company shall engaged as "Leader", the others shall be "Co-Insurer"
