INVITATION TO BID

The last date for submission of Tender is 7th August, 2025. Sealed Quotation Envelope (Technical & Financial in separate envelopes) shall be addressed to "Head of ICT, Community Bank Bangladesh PLC., Police Plaza Concord (Level 10, Tower 2), Gulshan 1, Dhaka-1212.", by 11:00 AM. These Bids (technical part) will be opened on same day at 03:30 PM. The bidder may depute their representative at the time of opening of Tender. Also note that technical proposal and live demonstration of the software will be evaluated after completing initial scrutiny of the required documents submitted along with the proposal. Financial proposal of the technically eligible bidders only, will be opened.

Executive Summary

Community Bank Bangladesh Limited. (CBBL) is a new generation private commercial bank, based in Dhaka, Bangladesh. CBBL is fully and owned by Bangladesh Police Kalyan Trust (BPKT). The Bank has vision growth strategy catering to the need of customers both in retail and MSME, who have limited access to finance. In this regard bank will have around 100 plus branches, 1000 booth over next 5 years and intent to cater 2.5 million plus customers through deployment of wider, alternative channels including mobile wallets.

Scope of Work

Scope of Bid

Bidders are required to propose solutions as specified in the technical and financial proposal for the supply, installation and implementation of following items. Bidders are required to propose their solutions under one envelop system. Bidders are required to quote for the items and are fully responsible for offered products and implementation of the same as specified in the terms and conditions.

The successful Bidders shall be responsible jointly and severally for all the products and services offered by them for project management and co-ordination of the supply, installation, integration, testing, training and commissioning for the implementation of the said items. During the course of installation the successful bidder will have to work together for final implementation for which they will be held jointly and severally responsible.

Sealing and marking of envelop

Bidders are required to propose their solutions under **one stage two envelop** system. Bidders are required to quote for the items and are fully responsible for offered service and completion of the same as specified in the terms and conditions, duly marking the envelopes as:

 - Bid Security of Taka 50,000.00 (Fifty Thousand) for the participated projects in the form of Payment Order/Demand Draft/Bank Guarantee in favor of Community Bank Bangladesh Limited. The bid security should be valid for 3 (Three) months after the date of bid opening and must be submitted inside the Envelope 1. The EMD such deposited [in the form of Pay Order] shall not carry any interest;

If the envelopes are not sealed and marked as required above, CBBL will assume no responsibility for the misplacement of bid documents in whole or in part or premature opening. If the envelope discloses the Bidder's identity, CBBL will not guarantee the anonymity of the bid submission, but this disclosure will not constitute grounds for bid rejection.

Bidder's qualification

- 1. The bidder must hold Manufacturer's Authorization Letter should be attached (MAF).
- 2. Experience of last 5 years involved in successful implementation of similar functional of technical platforms.
- 3. Must submit 05 (Five) Client list and having at least 03 (Three) organizations in the banking sector for the similar products.
- 4. The Tenderer Should Submit at least 2 (two) OEM certified B.Sc. Engineer's profile.
- 5. At least 01 (One) ongoing SLA for Server solution.
- 6. The bidder must be regular tax payer.
- 7. Trade License
- 8. certificate of in-corporation
- 9. TIN certificate

TERMS & CONDITIONS:

- 1. This invitation for Tenders is open to eligible tenderers from Local Company Only.
- **2.** The tenderer shall not be under a declaration of ineligibility for corrupt, fraudulent, collusive or coercive practices.

- 11. Finical offer should be valid for Minimum (06) Six months
- **12.** Price quotation includes carrying cost, labor charge and other charge thereof. No other charge will be allowed for all over the county.
- **13.** The bank will carry out a detailed evaluation of the quotation according to the information supplied by the bidder through its proposal.
