Quotation (BOQ with Technical Assessment Sheet attached herewith) is hereby invited RFQ (Request For Quotation) as well as Technical Specifications for supply of

i) 45 KVA Prime Diesel

at Community Bank Bangladesh PLC. Jashore Branch.

You are requested to submit (HARD COPY) your offer in a closed envelope as per below specification within 2.00 P.M. on October 16, 2025 addressing "Chairman, Purchase Committee, Community Bank Bangladesh PLC. (Tender Reference# CBBL/GSD/RFQ/2025/0090)

- ✓ Only relevant enlisted vendors are invited to submit their offer
- ✓ Supplier should be Authorized distributor for the mention goods. Distributor/Manufacturer Authorization letter should be attached.
- ✓ All price/ rate should be inclusive of Carrying Charge, Installation Cost and related Materials, VAT and Tax which will be deducted from source during payment of final bill after satisfactory completion of the works.
- ✓ Retention money will be kept i.e. 10% of the total payable bill will be kept for 01 (one) year.

Other terms, conditions and mode of payment will be as under:

- a) Ready stock will be given preference.
- b) Supplier should be authorized distributor for the mention goods.
- c) Required installation materials like Earthen, ATS, Power Cable (Brand-BRB), Control cable, Load distribution Cable, Ducting, Alternative charger, Silencer Pipe, etc. to be supplied and installed by Supplier. Must visit the site for actual measurement of the installation material.
- d) Total cabling in connection with installation of generator like cabling from Generator to ATS, main distribution panel to ATS and ATS to MDB should be done by the Supplier. In connection of this wiring, required materials also to be supplied by the Supplier.
- e) Date of delivery or completion of work will be counted from the date of Work Order/Letter of Intent received/acknowledged either by signing the photocopy of Work Order or by e-mail confirmation whichever is earlier.
- f) In the event of supply of the mentioned items, if the said items do not match with as per requirement/approved quotation then the Bank reserves full right of outright rejection of the items, and the supplier will have to take back the supplied items at their own cost and will have to replace the said items with acceptable within the time frame as mutually agreed-upon by the Bank and the Supplier.
- g) Selected bidders must ensure to site installation & testing on site after sales support on the full warranty period including all types of Fuel (50 Liter Fuel One Time Only), Mobil, Filter & other consumable spares etc. No additional bill/Service Charge will not allow for full warranty period. All types of service and consumable spare will replace full warranty period by selected bidder.
- h) The bidder shall have to submit the price in the letter head pad including VAT & Tax where the tax rate should have mentioned as per government Policy.
- i) Delivery Challan have to be duly received by relevant cost center (Head office, Branch, Sub-Branch, ATMs etc.) and submitted to be along with the bill.
- j) The product must be supplied as per specification mentioned in quotation. If any change, Supplier will have to consult and take prior approval from General Services Division, Head Office of the Bank.
- k) In case of deviation from the quality and specification and/or delay in supply, bank preserves full right to reject the materials and cancel the work order without showing any reason.
- I) In case of any deficiency in the delivered product, supplier will have to make necessary rectification the same immediately at Supplier own cost on receipt of complain.
- m) No additional bill/work will be entertained without prior permission of the concerned Division.





- n) The bidder must be regular tax payer.
- o) Financial offer should be valid for Minimum 06 (six) months
- p) Price quotation includes carrying cost, labor charge and other charge thereof.
- q) The bank will carry out a detailed evaluation of the quotation according to the information supplied by the bidder through its proposal.
- r) Considering the Experience, quality and other factors, CBBL is not liable to select the lowest bidder.
- s) Must Submit Trade License, TIN, 13 Digit BIN Copy
- t) The bank reserves the right to accept or reject any or all quotation at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Bank's action.
- u) For any type of sub-standard quality product from selected bidder end, the Bank reserve the right for outright rejection of the goods, which you will take back at bidder own cost and will replace with acceptable quality within (10) ten days of the rejection.
- v) The Tenderer must have experienced in banking industry. The Tenderer must have completed similar works for a minimum of three (3) scheduled banks during the last three (2) financial years. Documentary evidence, such as work orders and completion certificates, must be submitted in support of this requirement.
- w) Penalty will be imposed and deducted from the bills at Bank's discretion of total Work Order/Purchase Order amount in case of delay in each day/week/month. Bank MUST be informed in written for any foreseeable delay due to uncontrolled situations prior to exceed the delivery lead time which may be considered by the Bank if situations justify such delay.

Payment:

- > Bill should be submitted along with Work Order (Duplicate Copy) and Delivery Challan.
- All Price should be including all VAT and TAX. Necessary VAT & Tax will be deducted from your bill as per latest Govt. circular.
- Payment will be made after submission the bill only through account with Community Bank Bangladesh PLC. Thus, before final payment you have to open account with our Bank.
- Price includes delivery, installation including all installation materials, commissioning charges, consumable item (50 Liter Diesel- one time only) for full warranty period.
