- ✓ Only relevant eligible vendors are requested to submit the quotation.
- ✓ No advance will be allowed in this regard.
- ✓ All price/ rate should be inclusive of Carrying Charge, Installation Cost and related Materials, VAT and Tax which will be deducted from source during payment of final bill after satisfactory completion of the works.

**Other terms, conditions and mode of payment will be as under:**

- a) The bidder must have successfully completed minimum two (02) painting and finishing works for Banks/NBFIs/MNCs. Relevant Work Orders/Completion Certificates must be submitted.
- b) All materials including plastic emulsion, enamel, polish, weather coat, and PVC board must be branded, premium quality, and of approved standard. Sub-standard or expired materials will not be accepted.
- c) Workmanship must be of high professional standard ensuring smooth, uniform, eye-catching finish with clean and sharp bordering, suitable for banking premises.
- d) Proper surface preparation (cleaning, sanding, putty, priming, minor repair works) must be carried out and included in the quoted price.
- e) The contractor must provide a minimum six (06) months warranty against peeling, fading, cracking, blistering, or any workmanship defect. Rectification shall be done at contractor's own cost.
- f) The Bank may require a sample/mock-up work prior to full execution, and final work must strictly follow the approved sample.
- g) Work must be completed within the stipulated time and, if required, be carried out after office hours/holidays without additional cost, ensuring no disruption to Bank operations.
- h) The contractor shall ensure proper protection of existing furniture, fixtures, flooring, and equipment. Any damage caused must be repaired or replaced at contractor's own cost.
- i) Completed work shall be subject to inspection and acceptance by the Bank. Payment will be made only after satisfactory completion.
- j) In case of poor quality, deviation from specification, or delay, the Bank reserves the right to reject the work, order rework, or cancel the Work Order without any financial obligation.
- k) The bidder shall have to submit the price in letter head pad including VAT & Tax.
- l) Financial offer should be valid for 06 months. Upon expiry of the 1st 06 months, the offer validity may be extended for further 06 six months automatically, if both parties agree.
- m) Price quotation includes carrying cost, labor charge and other charge thereof.
- n) Date of delivery or completion of work will be counted from the date of Work Order received/ acknowledged either by signing the original copy of Work Order or by e-mail confirmation whichever is earlier.



- o*) In the event of supply of the mentioned items/services, if the said items/services do not match with as per requirement/approved quotation then, the Bank reserves full right of outright rejection of the items/services.
- p*) The product/services must be supplied as per specification mentioned in quotation. If any change, Supplier will have to consult with the General Services Division, Head Office of the Bank.
- q*) In case of deviation from the quality and specification and/or delay in supply of goods/service, bank preserves full right to reject the materials and cancel the work order without showing any reason.
- r*) In case of any deficiency in the delivered product/services, supplier will have to make necessary rectification the same immediately at Supplier own cost on receipt of complain.
- s*) No additional bill/work will be entertained without prior permission of the General Services Division.
- t*) Delivery Challan/Work completion certificate duly received by branch/Head Office is to be submitted along with the bill.
- u*) The bank will carry out a detailed evaluation of the quotation according to the information supplied by the bidder through its proposal.
- v*) Considering the Experience, quality and other factors, CBBL is not liable to select the lowest bidder.
- w*) Must Submit Trade License, TIN, 13 Digit BIN Copy
- x*) The bank reserves the right to accept or reject any or all quotation at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Bank's action.
- y*) For any type of sub-standard quality product/service from selected bidder end, the Bank reserve the right for outright rejection of the goods/services, which you will take back at bidder own cost and will replace with acceptable quality within (10) ten days of the rejection

**Payment:**

- Bill should be submitted along with Work Order (Duplicate Copy) and Delivery Challan and performance certificate signed by the Branch Authority.
- Price includes delivery, installation including all installation materials and commissioning charges.
- All Price should be including all VAT and TAX. Necessary VAT & Tax will be deducted from your bill as per latest Govt. circular.
- Payment will be made after submission the bill only through account with Community Bank Bangladesh PLC. Thus, before final payment you have to open account with our Bank.
